Specifically, the parties ask for this Court's order approving the following amendments:

That Exhibit A attached to the Settlement Agreement (the "Notice of Class Action Settlement and Approval Hearing") be amended by (1) revising the first sentence of section 9 thereof to read as follows: "**The settlement allows you to assign a portion of your Past Tax Payment, not to exceed five percent (5%) of the "subtotal" amount for you shown in Section 3 above, to the Missouri Municipal League or the St. Louis County Municipal League (if you are located within St. Louis County).**"; and further amended by (2) revising section 10, end of the first paragraph, to correct the URL of the Missouri Municipal League to read http://www.mocities.com.

And that Exhibit B attached to the Settlement Agreement (the "Claim Form") be amended by revising the first sentence of the section titled ASSIGNMENT TO MISSOURI MUNICIPAL LEAGUE OR ST. LOUIS COUNTY MUNICIPAL LEAGUE to read "**If you wish to assign part of your Past Tax Payment to the Missouri Municipal League or the St. Louis County Municipal League (if you are located within St. Louis County), please mark this box and enter the amount here: \$ _____ (the assigned amount may not exceed \$«cap»).**"; where «cap» will be a computed field equal to the lesser of (i) Past Tax Liability or (ii) 5% of Total Past Tax Consideration.

The Court finds that the requested amendment is acceptable and will not prejudice any parties to this action or members of the settlement class certified by the Court's prior order.


